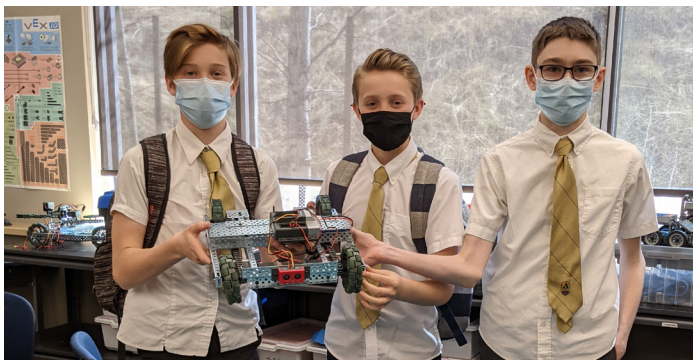
REPORTING ON THE 2019/2020 FISCAL YEAR

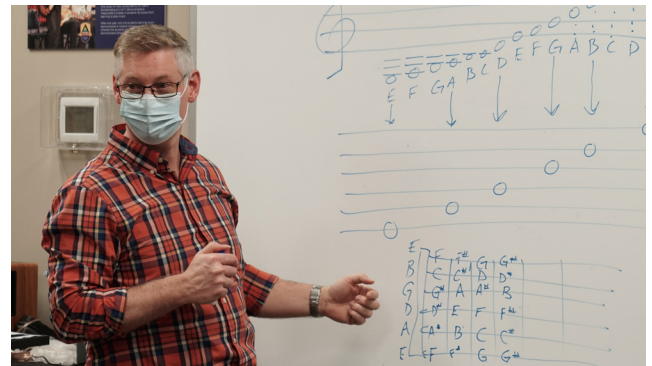


ADST ROBOTICS EQUIPMENT

By investing in more ADST resources we have been able to keep our popular robotics programming running this year while managing public health guidelines. The increase in resources allowed us to run smaller groups with less equipment sharing between cohorts.

ENHANCED MUSIC INSTRUCTION

The annual Gryphon Fund supports our enriched music program. Our students learn from experienced, professional musicians and have the opportunity to learn ukulele, violin, cello, guitar, and percussion. Students receive specialized instruction beginning in Kindergarten in an intimate teaching environment and many continue all the way through Grade 12. Students in the senior grades, learn to compose their own music in our professional in-house recording studio.



WIFI INFRASTRUCTURE

We have invested in more access points around all of the buildings on campus to increase coverage and capacity around the school. We even have WiFi in a lot of outdoor spaces such as the Senior School sports court area and the school field to increase all of the possible learning spaces around the school - this has been of particular importance during the Covid-19 pandemic when we try to learn outside as often as possible.

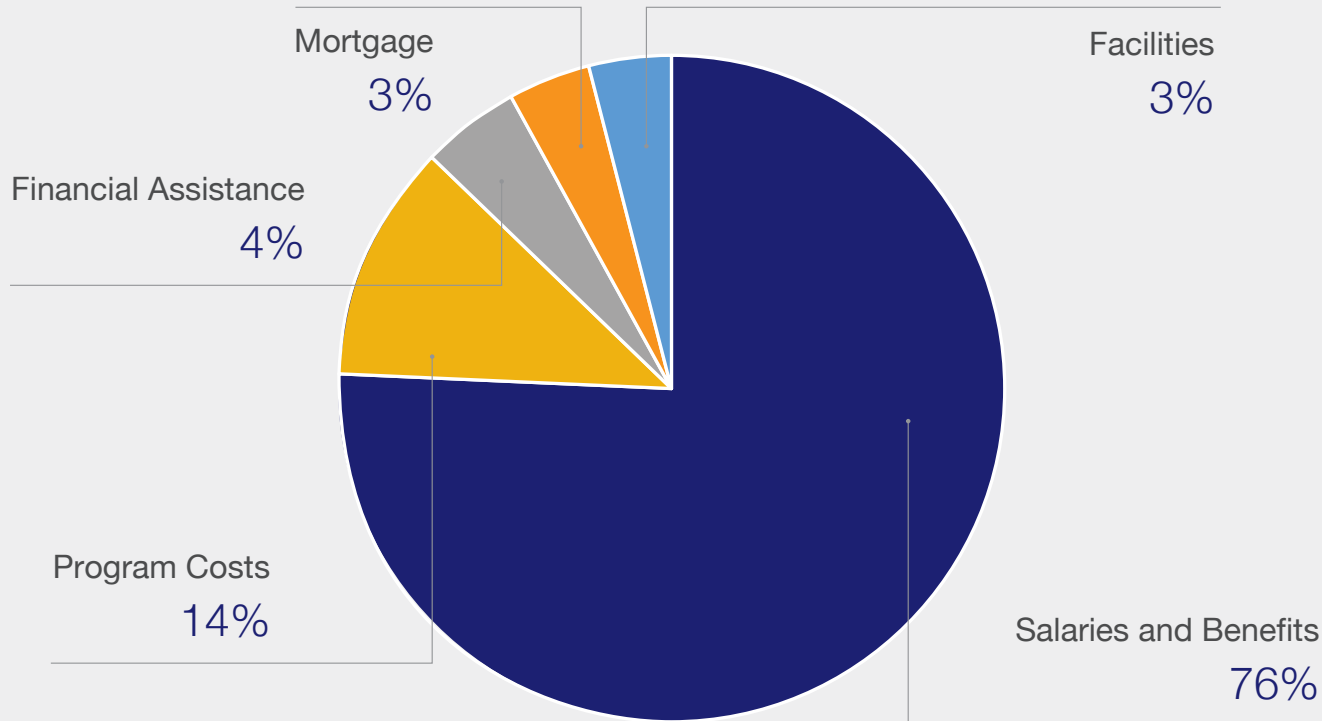

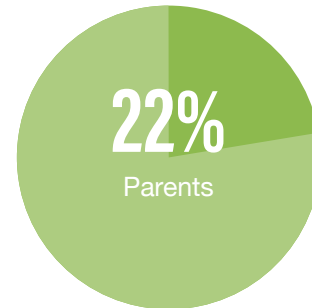
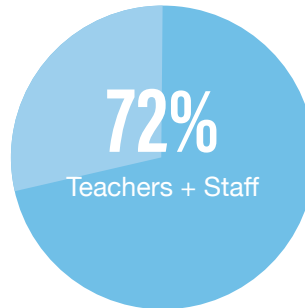
